## Rules and regulations

Thank you for choosing Nangiyala Safaris for your next hunting adventure. The activities involved in a hunt holds some risks, so these rules and regulations are there to protect both you, our valued client, as well as Nangiyala Safaris and ensure that you are completely satisfied, and leave here safe and sound with memories that will last a lifetime. This will only be possible if all of us understand each other completely. We therefore ask that you read these rules and regulations carefully, and once you completely understand them, please sign in the place provided below to show that you agree to them. Please feel free to ask our friendly staff if anything is not clear.

- 1) Nangiyala Safaris caters for the South African biltong hunters, as well as local and international trophy hunters. If you want to hunt a specific trophy animal, the trophy prices are also listed on the price list where applicable. The skinning of an animal for trophy purposes is an optional extra, please enquire from the Professional Hunter on duty and make arrangements before the hunt commences.
- 2) Minimum group size is 2 hunters and the minimum stay is 2 nights. Please communicate your arrival and departure times with Nangiyala Safaris well beforehand. No arrivals before 14h00 and no departures after 12h00!
- 3) 50% of the daily fees as per the pricelist is payable upfront as a deposit and only when the full deposit amount has been paid and received by Nangiyala Safaris, will the booking be confirmed. This deposit is only refundable if the booking is cancelled at least 30 calendar days prior to the arrival date.
- 4) The final payment (animals hunted and all extras) is due in cash or via EFT before departure. No exceptions will be made. The banking details for EFT payments can be found on the pricelist.
- 5) A list of species available for hunting as well as all the costs associated with the hunting of these animals is attached hereto (the Pricelist). Please initial it to indicate your acceptance. Please note that the price for any animal explicitly excluded for hunting will be R25 000 in the case that such animal is shot or wounded by a hunter.
- 6) Before any hunting activities begin, all hunters must sight their rifles on our shooting range in the presence of the Professional Hunter on duty. The typical hunting distance here is between 60m and 100m. Each hunter must therefore demonstrate that they can make 3 consecutive shots in a 20cm diameter grouping (representing the average heart / lung kill zone of the animals to be hunted). Nangiyala Safaris retains the right to deny the hunter to hunt if he or she is unable to demonstrate their capability in this way. This requirement is to ensure as far as possible that animals are killed in an ethical way with as little as possible suffering and to reduce the risk of wounding animals as far as possible.
- 7) Hunters will at all times be accompanied by a representative of Nangiyala Safaris while out on a walk-and-stalk hunt, this is not negotiable! The representative is there to make sure all rules are followed, to communicate with management to organise recoveries and for the safety of the hunter.
- 8) The representative of Nangiyala Safaris is there to point out animals and to make sure that the hunter is safe and does not get lost or stray outside of the designated area for that hunter. It is not the representative's duty to judge animal quality or trophy size and the final decision lies with the hunter making the shot.
- 9) Any blood, hair or body fluids on the flight path of the animal will be seen as a hit and the full price for the animal will be payable whether the animal is retrieved or not. We endeavour to do everything in our ability to retrieve all animals shot but the risk stays with the hunter if we are unable to retrieve the

wounded animal. **Please note that any wounded animals that were not retrieved by the time of the departure of the hunter will be forfeited.**

- 10) In the case where any animal of which both genders have horns is wounded, or where there is any doubt about the gender of the wounded animal, the highest price for a male of that species will be charged.
- 11) No shots at animals allowed in roads next to fences.
- 12) No alcohol consumption will be allowed during a hunt. The use of alcohol is limited to times after the hunt and Nangiyala Safaris retains the right to cancel a hunting session for a hunter if we feel that the hunter is intoxicated.
- 13) Hunters must stay in their designated areas as to control movement and/or prevent possible accidents. A hunter may request to be moved to another area if he/she deems their current area to be unproductive. The responsible Professional Hunter is on the reserve daily and will thus have the best knowledge as to which area/s is most productive for each species, and we endeavour to place the hunters in such areas as to maximise their chances of success.
- 14) No shots will be allowed after 1 hour before sunset. This is to ensure that we have adequate time for the animal to expire as well as to follow the trail and recover the animal. The exact times will vary upon the time of the year and will be communicated to the hunters before they set out to hunt.
- 15) You are welcome to give a gratuity, but no alcoholic beverages are to be given to any of the staff of Nangiyala Safaris. We also request that you give all gratuities for guides to the Professional Hunter on duty. He will make sure they receive it at an opportune time.
- 16) No firewood is to be collected from the farm. We will provide adequate firewood for the duration of your hunt.
- 17) Please do not litter! Everything that goes onto the vehicle must be taken off when you are returned to the camp site. This includes paper, bottles, plastic bags, fruit peels, cigarette butts etc. Please take note that no smoking is allowed on the vehicle or on foot in the veld, smoke breaks will be given at the Professional Hunter on duty's discretion.
- 18) You are welcome to make use of our abattoir to work your carcasses, please bring your own knives, spices etc.
- 19) Nangiyala Safaris retains the right to change or amend the rules and regulations and if done it will be discussed with the hunting party so that all parties involved are happy.
- 20) No use of private vehicles will be allowed on the farm.
- 21) No pets are allowed on the farm.
- 22) All breakages and/or losses at the overnight accommodation will be for the hunters account.
- 23) Right of admission is reserved.
